## Things to know before coming to Mauritius

#### Location

Mauritius is located in the Indian Ocean, approximately 500 miles/ 800 kilometers east of Madagascar and 125 miles/ 200 kilometers east of Réunion Island.

### Population

The current population of Mauritius is 1,301,191 as of Monday, December 11, 2023 (Worldometer elaboration of the latest UN data).

### Currency

The country's official currency is the Mauritian rupee (MUR). For up-to-date exchange rates, use this online converter. The Bank notes consist of MUR 25, 50, 100, 200, 500, 1000 and 2000.

## Cash Withdrawal

ATMs can be found at the airports and in shopping malls. Other locations allow you to withdraw cash by credit cards, debit cards including Visa and Master cards.

### What to wear

January is the hottest month of the year in Mauritius and it is peak season. However, it is also one of the wettest and most humid times of the year. The average temperature hovers around 26°C.

To facilitate health surveillance procedures upon your arrival in Mauritius, you are kindly requested to fill the online "Mauritius All-in-One Travel Digital Form", preferably before boarding, please visit

• Mauritius is open to everyone, both vaccinated and unvaccinated.

•No testing is needed before flying to Mauritius or on arrival.

•You do not need to wear a face mask during your holiday. It is only recommended in airports, during airport transfers, on public transport and in healthcare facilities For more information, please visit Direction & Transportation

It is recommended to stay in the western region of the island. The hotel can offer only SINGLE ROOMS for this request and they will have the Corporate rate valid till Monday, 11 January 2024 (depending on the rooms availability at the hotel) to book their room at Hilton Mauritius Resort & Spa.

The hotel is proposing a single rate per room per night on a Bed & Breakfast basis; approximately MUR 17, 500/ EUR 352.15/USD 393.97 per night (USD=MUR 44.42.
